All deposits are non-refundable. You pick up in the order you are on the list. Full payment is made at 8 weeks of age when you pick out and pick up your puppy. We occasionally keep puppies until 9 weeks old.

Breeder's Guarantee:

At this time of sale, breeder guarantees that puppy has been checked by a Veterinarian, is healthy, sound, and current on all vaccinations and deworming.

Vet Records will be furnished at time of Purchase. If puppy is being shipped, a copy of vaccines and deworming records will be shipped to the buyer. Buyer agrees to have the puppy examined by a licensed veterinarian of their choice within 72 hours of receiving the puppy to validate that the puppy is healthy. Breeder is not responsible if puppy contracts a communicable disease after 72 hours of leaving breeder's possession. Puppy is not to be purchased for re sale and will never be sold to a person, pet shop, puppy mill or agent of same. If the Buyer is unable for any reason to care for their golden, they must return it to the breeder. The owner is responsible to return the dog to breeder in good mental and physical condition. No refund is given for this return. Puppies are sold under spay/neuter Contracts. We recommend doing this at 7 months of age for females and 8 months of age for males. No litters can be produced by their dog. After the dog has been spayed/neutered and we receive a veterinarian certificate with microchip number of verification, then you will get your AKC registration papers. If puppy is not spayed/neutered at 8 ½ months, breeder has the right to pick up the puppy with no refund. We do this to help control the pet population and also to protect our lines. Buyer is not to register the puppy under any other Pet Registry, other than American Kennel Club (AKC). Puppy is sold on Limited Registration.

Breeder offers Full 1 year guarantee with written documentation from two qualified veterinarians (one be the OFA examiner) and veterinary ophthalmologists. The animal may be returned to Breeder for a replacement puppy within 12 months for the defects of crippling genetic hip dysplasia requiring surgery or euthanasia from OFA reading, or buyer will keep the puppy and breeder will refund up to half the original purchase price. Breeder must receive the official copies of OFA documentation. Any replacements are only made on the condition that the dog is covered by this contract, has been spayed/neutered, we receive a veterinary certificate with microchip number of verification and all vet exams. We reserve the right to have a second opinion from our veterinarian. We also reserve the right to acquire DNA on the dog or puppy. Any refund is only given after a Non-Disparagement Agreement is signed. Breeder does not cover worms, giardia, coccidiosis, mites and fleas, or any other parasites as they are common in dogs and puppies. Breeder does not guarantee size, color, championship, training, or temperament of any puppy, and will not be held responsible for any veterinarian or shipping fees after leaving the premises. This contract is null and void if the dog receives oral flea or tick medicine, or becomes obese or underfed at any time. Evidence of neglect or abuse, injuries, evidence of strenuous exercise -no treadmill, no steady jogging, no jumping, no flights of stairs until four months, no running down the road before two years of age, no steady, long mile walks before one year of age (when on long walks stop often), no excessive tennis ball chasing especially on slippery floors (the best exercise is swimming), or not keeping your dog on premium quality dog food, or if the dog has been bred, this contract is null/void contract.
